- The Government of Republic of Cabo Verde has received financing from the International Development Association (hereafter named "World Bank"), the Credit ref. 6792-CV to fund the Digital Cabo Verde Project, designed to contribute to transforming the country into a regional digital hub for accelerating its digital economy through and enhanced digital infrastructure and strengthened demand of digital services and skills, and intends to apply part of the proceeds for consulting services.

The objectives of the Consulting Services ("the Services") are, among others, to advise and support the Government to: (i) Develop a technology vision and governance model for the implementation of CV's ICT strategies, policies, initiatives, projects and programs based on international best practices; (ii) Create a definition and oversight of Information Management practices, uses and outcomes for the management of CV's ICT infrastructure, systems, platforms and service delivery; (iii) International best practices and success examples on the implementation of policies and initiatives to enhance the digital entrepreneurial ecosystem; (iv) Provide guidance on the Monitoring and Evaluation of the implementation of all initiatives related to the digital transformation; (v) Provide support and guidance to a Team of experts with the responsibility to monitor continuously de digital transition in Cabo Verde.

- Previous experience in the design and implementation of policies related to digital development for at least 4 years.
- Relevant experience in the implementation of ICT projects or initiatives with the public or the private sector, will be a plus.
- Experience at the Ministerial or vice-ministerial level at a Ministry in charge of ICT portfolios, will be a plus.
- Knowledge of Cabo Verde or similar Country in digital ecosystem (public and private) including the Telecommunications sector, will be a plus;
- Good technical knowledge of ICT infrastructure, platforms and systems and capacity to provide technical recommendations.
